

Call for Entries

Arts Hub Mural Project Scope

The Art Underground is seeking a professional artist(s) to create a wall mural on our new Arts Hub facility located at 420 Courtney Way, Lafayette, CO 80026. This approximately ~7' x 20' mural will provide the backdrop for our future outdoor performance space. Viewable from the street, and therefore an integral part of the community art scene, the mural's theme must represent Lafayette's creative, diverse, and eclectic culture. The mural's placement is guaranteed for at least one year from the date of completion.

Submitting artists should be comfortable and experienced working with installations of this size and with the method of painting directly on the building's façade. Finalists will be selected based upon a review of past work (please include some of similar scale) as well as a full proposed mural drawing that fits on a 8 ½" x 11" sheet. Once a finalist is notified, they will need to send in a 1ft x 1ft to scale model with the actual coloring of proposed mural.

Working with TAU staff, the Artist will be responsible for the installation and preparation of the work site. There is a \$3,000 stipend for this project.

If comfortable, Artists are welcome (and encouraged) to include an educational aspect to their submission (scheduled Q & A's at the site, demonstrations on technique, etc.). These intended educational aspects may be included in the application.

Timeline

Initial submissions are due **April 22nd, 2016** by **5:00pm MST**. All requested materials must be included in the application.

Finalists will be notified by **April 29th**

Finalists' second art submission is due **May 9th**

Voting/panel discussions will be conducted **May 10 – May 13**. Finalists may be brought in for additional questions during this time.

The winning artist will be notified by **May 18th**

The mural must be completed in its entirety by **August 27th, 2016** (The Arts Hub 2016 Open House).

Artists will provide their on-site equipment and supplies.

Artists will be expected to carry their own general liability insurance and work at their own risk.

Artists must own the rights to all artwork submitted for approval.
